APOaccess Portal Terms of Service

OVERVIEW

- This website (*APOaccess Portal*) is operated by Apotex Pty Ltd (ABN 52 096 916 148) and its parent Arrotex Pharmaceuticals Pty Ltd (ABN 30 605 552 234) (together *Arrotex*). Throughout the site, the terms "we", "us" and "our" refer to Arrotex. Arrotex offers this website, including all information, tools and services available from this site (*Services*) to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.
- 2. You should read these Terms of Service carefully before accessing or using the APOaccess Portal. By accessing or using any part of the site, you agree to be bound by these Terms of Service. If you do not agree to all the terms and conditions of these Terms of Service, then you must not access the website or use any Services. If the availability to use the APOacess Portal is considered an offer, acceptance of that offer is expressly subject to these Terms of Service.
